Notice is hereby given that a regular meeting of the Board of Directors of the East End District (the "District") will be held on **Thursday, June 27, 2024, at 3:30 p.m.**, at the District offices, 3211 Harrisburg, Houston TX 77003, to consider, discuss and adopt such orders, resolutions or motions and take such other direct or indirect actions as may be necessary, convenient, or desirable with respect to the following matters:

1. **Receive Public Comments in accordance with adopted procedures.**
2. **Consent Agenda:**
 - a. **Assessments.** Receive report on collection of assessments and authorize appropriate action.
 - b. **Minutes.** Approve minutes of previous Board meeting(s).
 - c. **Emergency Action Delegation to Executive Committee.** Consider and approve authorization of the East End District Executive Committee to make decisions on behalf of the East End District for the month of July 2024.
3. **Board Appointment.** Consider Board Appoint for vacant position on East End District Board of Directors:
 - a. Approve Sworn Statement and Oath of Office for appointed Director; and
 - b. Authorize filing of updated District Registration Form.
4. **Financial Reports.** Receive and approve the Financial reports on revenues and expenditures, the Finance Committee report, and authorize appropriate action.
5. **Investment Report.** Receive the Investment Report and authorize appropriate action.
6. **Security Report.** Receive a security report related to Precinct 6 Security contract, the Law Enforcement Coordination Team meeting ,and a briefing on public safety initiatives planned for the District.
7. **Second Amendment to the Agreement Between Harris County and East End District.** Review and consider a second amendment to the agreement between Harris County and East End District to authorize funds in an amount not to exceed \$20,000 for Precinct 6 patrol officer overtime pay.
8. **Civility Ordinance Report.** Receive an update from staff regarding the status of the Civility Ordinance effort for Harrisburg Blvd.
9. **Road and Rail Safety Program.** Receive an update on a District application for additional funds from the Federal Highway Administration for the upcoming FY24 Safe Streets for All Grant.
10. **METRO University Corridor.** Receive report related to the METRO University Corridor announcement.
11. **Houston Bike Share.** Receive report related to the announcement by Houston Bike Share, also known as "Houston BCycle".

13. **Executive Session, if Necessary.** Convene executive session to discuss: (a) pending or contemplated litigation or to consult with the attorney in accordance with Section 551.071 of the Texas Government Code; (b) acquisition of real property in accordance with Section 551.072 of the Texas Government Code; (c) personnel matters in accordance with Section 551.074 of the Texas Government Code; (d) to receive information from or question employees in accordance with Section 551.075 of the Texas Government Code; (e) deployment of security personnel or devices or a security audit in accordance with Section 551.076 of the Texas Government Code; or (f) economic development negotiations or offers of financial incentives for economic development in accordance with Section 551.087 of the Texas Government Code.
14. **Reconvene in Open Session.** Reconvene in public session to consider authorizing District staff and consultants to take any action necessary with respect to (a) pending or contemplated litigation or attorney advice; (b) acquisition of real property; (c) personnel matters; (d) receiving information from or questioning employees; (e) economic development negotiations or offers of financial incentives; (f) deployment of security personnel or devices or a security audit; and (g) any other matters relative to any of these matters which was discussed in Executive Session.
